7. Construction Issues

8. Association Cottage

P. Heslin updated the Board on the cottage. It was the consensus of the Board to take action in the form of a lien for unpaid rent if the renter has not paid in full by July 31, 2018.

The Board discussed possible options for the future of the cottage. Some of the options included:

- Sell the property
- Tear down with possible recreation amenities installed
- Fix and rent either year round or by the week in summer and academic in the winter
- Repurpose into a store or snack stand (requiring zoning change)
- Fix and rent to a general manager and/or security manager

MOTION: (Cosentino/Paul) to go into Executive Session for the purpose of discussing legal issue pertaining to the cottage. Attending: Heslin, Cosentino, Paul, Malory, Burger, Knowles, Spang. Vote: Approved Unanimously The Session started at 8:30 and ended at 8:39.

It was the consensus of the Board to present the top three options to the Association members:

- Rent the cottage
- Tear down for possible recreation
- General manager/security manager

The options will be presented to the Association at the July meeting. Members will be encouraged to give feedback on which option they prefer. The August meeting will be a presentation of details with a vote to include absentee ballots at a future meeting.
